Anti Ragging Cell

The college follows, University Grants Commission (UGC) Regulations on Curbing the Menace of Ragging in Higher Educational Institutions 2009 (under Section 26(1) (g) of the University Grants Commission Act, 1956).

The college provides safe environment and prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in the college and thereby, to provide for the healthy development, physically and psychologically, of all students.

Objectives

1. To provide a safe, secure, supportive and healthy environment for the holistic growth of the individual
2. To inculcate respect and dignity for fellow human beings
3. To ensure unhindered access towards higher education and career goals

What constitutes as Ragging?

1. Causing, inducing, compelling or forcing a student, whether by way of a practical joke or otherwise, to do any act which detracts from human dignity or violates their dignity;
2. Exposes the individual to ridicule;
3. Compels the individual to forbear from doing any lawful act by:
4. Intimidating, wrongful restraint, wrongful confinement, or injuring the individual by using criminal force;

5. Threat of intimidation, wrongful restraint, wrongful confinement, injury, or the use of criminal force.
6. Any action that can threaten the physical or mental health of an individual.

Complaint process

1. A written complaint shall be submitted to any of the Anti-ragging committee member/Management authorities.
2. Complaints shall also be made online through the college website (by email).
3. The anti-ragging committee shall conduct a thorough unbiased enquiry and submit the report to the Principal within seven working days.
4. If any student/research scholar/alumni is found guilty of ragging after enquiry, the action shall be taken by the Principal and Chairman of the committee.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments.

- Debarring from appearing in any internal test/main examination
- Withholding of Marks Card.
- Suspension from attending classes and academic privileges
- Withdrawing scholarships and other benefits
- Suspension from the college for a period of one month
- Cancellation of admission.
- Debarring from representing the institution in any regional, state and national meet, sports tournament, youth festival, etc.
- Expulsion from the institution and consequent debarring from admission to any other institution.
